SECTION A: COMPULSORY (40 MARKS)

QUESTION ONE

(a) Patrick Agaba sold a motorcycle number UCE 169K to Joseph Mulenga at Shs. 4,500,000. Joseph made an initial deposit of Shs. 3,000,000 and paid the balance of Shs. 1,500,000 after one month.

Joseph has been riding the bike for the last eight months. On 25th September 2018. Joseph was arrested for the reason that the motorcylce he was riding was a stollen property having been stollen from Yowana Okedi. The motorcylce was removed from Joseph and handed over to Yowana Okedi.

Joseph is devastated and wants the full price he paid for the motorcycle.

Required:

Advise Joseph. (10 Marks)

(b) Gideon Bwambale is a business man based in Kasese. Gideon's wife, Mary Masika works with Exim Bank as a teller. Gideon Bwambale has an account with Exim Bank, Kasese Branch. On 22nd September 2018 Bank of Uganda officials went to Exim Bank, Kasese Branch and requested for details relating to Gideon's account and the transactions thereon. The manager of the bank readily handed over the details to the Bank of Uganda officials. Mary Masika called her husband Gideon and recounted to him whatever transpired.

Gideon Bwambale has come to consult you on the release of information on his account to Bank of Uganda officials and the possible remedy he could have against Exim Bank.

Required:

Advise Gideon Bwambale.

(c) James Odongo wanted to sell his land at Buwate in Wakiso District. Odongo was advised by his friend that the land could fetch Shs. 250,000,000. However, Odongo's Lawyers, Mwoto and Company Advocates informed him that no one would give him that much money. Mwoto and Company Advocates persuaded Odongo to accept Shs. 100,000,000 and the Lawyers bought the land from him at that much.

Four days after selling the land to the Lawyers, Odongo was approached by Keneth Ojok who is ready to pay Shs. 300,000,000 for the land in question.

Odongo is confused and he feels he has been cheated. Odongo now comes to you to advise him whether he can recover the land from the Lawyers and sell it to Keneth Ojok.

Required:

Advise Odongo. (10 Marks)
